- i) on the Standing Committee on Resource Stewardship, that Mr. Yao replace Mr. McDougall, and that Mr. Boitchenko replace Mr. Sinclair.

- (d) in clause (h) by striking out “that Mr. van Dijken replace Ms Lovely as Chair, that Mr. van Dijken replace Ms Lovely, that Mr. Cyr replace Mr. Long, and”.
